Treasurer's report for year ended 31st December 2018

The annual turnover this year, compared to the previous year, was much higher. This was because the Area engaged in more activities for its players.

The Area invested in judo mats, to the value of £11 130 to enable it to put on competitions with four mat areas. The cost of these was partially met by a lottery grant of £7420 which was negotiated by the committee. Ros Edwards took the lead in securing the funding.

The remainder of the expenditure on equipment represents further investment in the IT equipment for running events.

The Area organised a trip to France and to Holland for the up-and-coming players. The cost of the latter was partially met by a grant from the BJA trust of £2000. Note that the heading 'player support' has been subsumed into the activities and expenses of the squad.

The membership rebates for the year were slightly inflated because there was a backlog of payments due to us from the BJA from the previous financial year, not due to a massive increase in membership!

The miscellaneous expenses figure includes £510 paid in Dan grade levies to the BJA and the remainder is the cost of the website.

The expenses figure is high due to the trips to France and Holland, and the large area events that were staged during the year. We are indebted to the officials who enable our events to take place. Not only do they perform their roles with dedication, but many of them make substantial donations to the area by waiving some of their expenses. In the accounting year ended December 2018 these donations amounted to £682.
